RULES & REGULATIONS

The candidates who have been registered for Ph.D. program on or after 11th July 2009 are governed by UGC (MINIMUM STANDARDS AND PROCEDURE FOR AWARD OF M.Phil./Ph.D. DEGREE), REGULATION, 2016 PUBLISHED IN THE GAZETTE OF INDIA, DATED 05TH May, 2016.

Adhering to this, Dr. C.V. Raman University Bilaspur, has formulated the rules and regulations for Ph.D. programme and its Ph.D Course Work.

1. ADMISSION:

The admission to the Ph.D. program shall be through entrance test followed by the Interview.

R-1.1 All the Candidates have to appear in Pre-Ph.D. Entrance Test organized by the University (CVRU) as per rules which will be followed by an interview to be organized by the University as the case may be.

R-1.2 The Preference for Ph.D. Registration will be given to the Candidates having M.Phil./MS degree.

2. COURSE WORK

R-2.1 After been admitted to the Ph.D. Programme, the scholar will have to undergo course work. The course work shall be treated as pre-Ph.D. preparation.

R-2.2 The course work will be carried out in the departments of the University. Under special circumstances scholar may be permitted to complete the course work outside the University at recognized centers subject to prior permission by the University.

R-2.3 The Scholar, who is already having the M. Phil degree if admitted to Ph.D. programme, is exempted from the Ph.D. course work by the department. He/ She is required to submit the proposed synopsis for approval of RDC.

R-2.4 The Scholar on successful completion of the course work will be required to submit his/her proposed synopsis. On the approval by Research Degree Committee (RDC), Scholar will be registered for pursuing Ph.D. programme.

R-2.5 If the Scholar fails to complete the course work he/she will be required to pursue it again (only one chance) as per rules.

R-2.6 The structure for Ph.D. course work for all disciplines is as given in Table-1 below.

3. COURSE WORK ASSESSMENT:

The rules given below are specified for the examination scheme mentioned in the particular course work structure as shown in table-1.

R-3.1 Continuous Assessment:

The continuous assessment of Ph.D. course work for all disciplines will be done by concerned and appropriate faculty of the research centre.

R-3.1.1

The continuous assessment of Ph.D. course work of the paper Research Methodology, Subject paper and Report writing on literature review & Presentation will be evaluated on the basis of the class tests/assignments/case studies.

R-3.1.2

The presentation of report writing on literature review will be conducted in the concerned department.

R-3.2 *End Semester Examination (ESE)*

R-3.2.1 The End semester Examination for the theory courses are as follows

a) Research Methodology	3 Hours duration	70Marks
b) Subject paper	3 Hours duration	70 Marks

R-3.2.2 *Passing marks in each course and report writing will be 55%.*

4. RULES OF EXAMINATION & PERFORMANCE REQUIREMENTS (Course Work)

R-4.1 The Authority of Dr. C.V.Raman University, Bilaspur will be responsible for paper setting, preparing the schedule of the examination, conducting the examination, appointment of examiners, assessment & awarding the marks for the ESE of the course.

R-4.2 All the Scholars admitted in Ph.D. programme will have to appear in course work examination.(Exemption will be made as per **R-2.3**)

R-4.3 Those Scholars who have failed or found absent in Pre Ph.D. course work examination will be given a chance to re-appear in the next course work examination as to be scheduled there on later.

R-4.4 The registered candidates for Ph.D. will have to undertake Teaching assignments as assigned by respective head of the Department.

R-4.5 Inter-University transfer is permitted as and where basis. (Subject to the approval by VC)

5. RULES FOR THESIS WORK:

Upon satisfactory completion of course work, scholar should undergo research work and produce a drafted thesis within a reasonable time.

R-5.1 Ph.D. programme will be for a minimum duration of three years, including course work and a maximum of six years.

R-5.2 The Scholar must put in at last 200 days attendance including actual attendance he/she will earn during the course work.

R-5.3 The Scholar will be required to submit a six monthly report of his/her progress duly signed by his/her supervisor/co-supervisor if any, along with copy of fee receipt, otherwise the report will not be accepted.

R-5.4 If the progress of work is not found satisfactory in two successive reports or no reports are received for a period of one year and the scholar fails to deposit fee, then the VC has the authority to cancel the name of the scholar from the list of those registered for Ph.D. degree and no fee will be refunded as paid earlier.

R-5.5 Prior to submission of the thesis, the scholar should prepare and present a pre-Ph.D. presentation in the department that may be open to all faculty members & research students for getting feedback and comments, which may be suitably incorporated into the drafted thesis under the advice of the supervisor.

R-5.6 The length of summary should be between 10-25 pages and Thesis not less than 100 pages.

R-5.7 Ph.D. Scholars must publish at least one (01) research paper in UGC CARE Listed Journal (Scopus/Web of Science) and make two (02) papers presentations in conference/seminar before the submission of the thesis for adjudication and produce evidence for the same in the form of reprints.

R-5.8 The Scholar should submit three (3) copies of the summary of the thesis along with one soft bound copy (MS Word/ Kruti Dev), one copy of published research paper and 2 Papers presentation Certificates in conference/seminar through his supervisor to the concern Department and the DRC will verify it before submission in research cell for summary presentation.

R-5.9 After successfully presentation of the summary of the Thesis by the scholar, he/she will be eligible for submission of his /her Ph.D Thesis within 3 months from the date of approval of summary.

R-5.10 The Scholar should submit 3 copies of his/her thesis in Hard bound copy along with 2 soft copy in CD (word file/ kuruti dev) for evaluation.

R-5.11 Reprint of one research paper published in UGC CARE listed journals and 2 papers presented in conference/ seminar etc. relevant to the topic of research much be attach in Summary / Thesis.

R-5.12 Acceptance letter will not be considered as published research paper.

R-5.13 The research scholar are advise to strictly follow the format.

R-5.14 The thesis must be accompanied by a declaration from the scholar that the thesis embodies his/her own work and he/she has worked and investigated under the supervision of the supervisor.

R-5.15 The certificate from the supervisor together with co-supervisor, if any, that the thesis fulfills the requirements of the ordinance ruling to the Ph.D degree of the University is to be submitted.

R-5.16 The Scholar should also submit the examination fee witin time during the submission of Thesis.

R-5.17 The plagiarism report of the thesis must be attached in annexure of the thesis.

Guidelines for preparation of Summary / Thesis for Ph.D. (Program)

The Ph.D. Summary / Thesis is an important academic document that reflects the research aspirations and objectives of the University, and has an infinite life time. A good. Summary / Thesis should be clear and unambiguous and have a logical structure that should assist the reader's, understanding of the argument being presented. Therefore, it is expected, to comply with the following general guide lines.

SUMMARY / THESIS FORMAT

The Summary / Thesis consists of three main parts (i) The Preliminaries (ii) The Text (iii) Annexure. It is to be arranged in the following sequence.

THE PRELIMINARIES:

- ❖ Title Page (Outer Cover) as per the format given in Annexure I, **(should be printed in White Colour on a Navy Blue background).**
- ❖ Title Page (Inner Cover) as per the format given in Annexure II.
- ❖ Declaration by the candidate (Annexure – III)
- ❖ Certificate of Supervisor/s (Annexure – IV)
- ❖ Acknowledgements (Annexure – V)
- ❖ Table of Contents (Annexure – VI)
- ❖ Abstract/Preface
- ❖ List of Tables (If applicable)
- ❖ List of Figures (If applicable)
- ❖ List of abbreviations (Optional)
- ❖ Chapter –I tocontinue according to the table of contents.

THE TEXT OF THE THESIS

The text the thesis is usually divided in to chapter's with subheadings, within the chapters to indicate the orderly progression of topics and their relation to each other

Chapter-I Introduction: - The thesis should normally begin with a general introduction presenting an overview of the purpose and significance of the study. The introduction should show why the topic selected is worth investigating. This will normally be done with reference to existing research, identifying areas that have not been explored, need to be explored. The final section of the introduction should provide a brief overview of each of the main chapters that the reader will encounter.

Chapter-II Review of Related Literature: - The purpose of the literature review is to summarize, evaluate and compare the main developments and current database in the field which are specifically relevant to the subject of research embodied in the thesis.

Chapter-III Research Methodology : - The supervisor and the student may decide how this part of the thesis should be structured. Although this section varies depending up on method and analysis technique chosen, the chapter describes and justifies the methods chosen for the study and why this method was the most appropriate.

Chapter-IV Observations & Analysis:- Observations , Analysis and Interpretation should be done as per data collected from sample.

Chapter-V Results Conclusions and Suggestions: The results are actual statement of observations, including statistics, tables and graphs. Do not present the same data as graph as well as table. Use one of the appropriate style of presentation. The purpose of this chapter is not just to reiterate the findings but discuss the observation in relation to the theoretical body of knowledge on the topic.

Chapter-VI Summary: Start with a few sentences that summarize the important results and conclude by giving the strongest and most important statement that highlights the outcome of the study. The conclusion should provide answers or solutions to the questions or problems raised in the introduction chapter.

Reference/Bibliography Citation in Text: Citation in the text usually consists of the name of the author(s) and the year of the publication. The page no is added when utilizing a direct quotation. It should be arranged Alphabetically .

3. Margins.

At least 1¼ -1½ inches (3.17-3.81cm) on the left-hand side, 3/4 - 1 inch (2 - 2.54cm) at the top and bottom of the page, and about ½ - 0.75 inches (1.27 - 1.90cm) at the outer edge. The best position for the page number is at top-center or top right ½ inch (1.27 cm) below the edge. Pages containing figures and illustration should be suitable paginated.

4. The Summary / Thesis shall be computer typed (**English**- British, Font Style -Times Roman, Size-12 point, **Hindi**- Font Style -Krutidev-10,Size-14) and printed on A4 size paper.
5. The Summary / Thesis shall be typed on one side only with double space with appropriate margin.

6. Use only standard abbreviations. Avoid abbreviations in the title. The full term for which an abbreviation stands should precede its first use in the text except in case of measurement units. The measurement units if any shall be followed consistently.
7. Maintain uniformity in writing the Summary / Thesis.
8. All copies of the *Thesis* are to be bound in colored hard cover (according to color code) of the *Thesis*.
9. Title of the *Thesis*, the name of the supervisor(s) and the scholar should also be incorporated in a vertical manner in the binding spine (outer vertical edge) of the *Thesis*.
